Have a knowledgeable person come in to give a presentation to parents and students about social media. Many parents have requested informational guidance on this topic. This will be a goal. Review facility needs including an energy audit. Tell the town a building extension will be needed to hold the students if development continues at the current pace. Consider a CRF to begin saving toward major projects such as the addition, another building or renovation of the current building to prevent/reduce a bond. The SAU will discuss this possibility with the DRA.

6. Discussion: I think ______ needs to be a major priority next year.

Full day kindergarten/readiness discussion, space needs/demographic trends, communication with taxpayers, the Selectmen and Town Administrator.

7. Discussion: How can the SAU or School Administration better support the New Boston School Board?

Work with the Goffstown Board and unions on how to make up snowdays. The SAU was very responsive this year.

BUDGET PHILOSOPHY

Next year's budget preparation begins in July. The Warrant is expected to include a proposed support staff contract and a request to deposit into the Building and Renovation CRF as savings will be needed for future heating system and paving needs. Now that a deposit to the 2.5% CRF is planned, extra seats that have been included in each year's budget are expected to be removed from the next budget cycle. The Board recommended the budget continue to be conservative, responsible and fair. A CRF to begin saving toward major projects such as the addition, another building or renovation of the current building to prevent/reduce a bond will be researched.
